From the Director of Collegiate Education, Letter Rc.No.47187/52/71, dated 26.9.1972.

ORDER:

The Government approved the opening of four colleges mentioned in the Annexure to this order, for purposes of aid from State Funds for the courses mentioned against each, from the year 1972-73, subject to the following conditions:

- a. The various conditions specified in the Grant-in-aid Code and the condition relating to reservation of seats to Scheduled Castes, Scheduled Tribes and Backward Classes, grant of fee concessions etc., shall be complied with;
- b. The rules and orders issued by the Government or the Director from time to time, in regard to levy of tuition fees, special fees and other matters shall be strictly followed;
- c. The managements of the colleges shall pay the staff from 1972-73, revised scales of pay recommended by the Tamil Nadu Second Pay Commission and adopted by the State Government failing which teaching grant due to the college for the period for which such scales of pay has not been implemented, shall not be released;
- d. Teaching grant shall be assessed only if the management have entered into agreements with teachers, as required under the rules;
- e. Teaching grant shall not be assessed in respect of such of the teaching staff as are handling the subjects or language or course, the minimum strength of which is less than 20 students, provided that in the case of minority languages, this condition will be relaxed by the Director, if specific reasons are adduced for the uneconomic strength.
- f. The initial provision of land, buildings, equipment, book etc., required for the college shall be borne in full by the management and no non-recurring grant for any of these purposes will be admitted from State Funds towards such initial provision;
